Experience: The individual must have a minimum of three years of full-time professional experience in financial planning.

Examination: The individual must pass a comprehensive certification exam covering topics such as financial planning, risk management, tax planning, and retirement planning.

Ethics: The individual must adhere to the CFP[®] Board's Code of Ethics and Standards of Conduct, which include principles such as integrity, objectivity, professionalism, and confidentiality.

Once an individual has met these requirements, they can apply for certification as a CFP[®] professional. To maintain their certification, CFP[®] professionals must complete ongoing education requirements and adhere to the CFP[®] Board's ethical standards. Overall, the CFP[®] certification is considered the gold standard in financial planning, and CFP[®] professionals are widely recognized as having the knowledge, skills, and experience to provide expert financial planning advice to their clients.
